- IX. 4H Staff Spotlight
  - a. 4HOnline Enrollment Time: All registered 4-H volunteers and 4-H youth may now enroll in 4HOnline again, starting today. Remember to choose the county where your primary club is held, even if you don't live in that county. Please go to https://v2.4honline.com/#/user/sign-in to re-enroll (if you have been a past member) or enroll (if you are a brand-new member). Please reach out to your specific county office for assistance with this process.
  - b. 4-H Volunteers: We have several changes for this year with procedures, especially in Volunteer Central. You now need to complete the authorization for background checks in your birth month each year, not necessarily in the fall with the fall leader updates. Please pay attention to those emails that you will receive letting you know to complete that process. Questions? Reach out to your local 4-H staff.

  - d. 4-H Club Leaders: We must have every club complete the Annual Financial Summary Report prior to October 28th this year—no exceptions. Even if your club does not have a bank account, you still need to complete this form (with lots of zeroes on it). We also need the signed Civil Rights Compliance form, as well as a copy of your club minutes from last year (September 1, 2021-August 31, 2022). Each county may have other paperwork for you to fill out, but these three are required by MSU annually for your club to be considered active in the system. We also want to remind all clubs that in order to be a club, you must have 5 youth members, from at least two different families.
